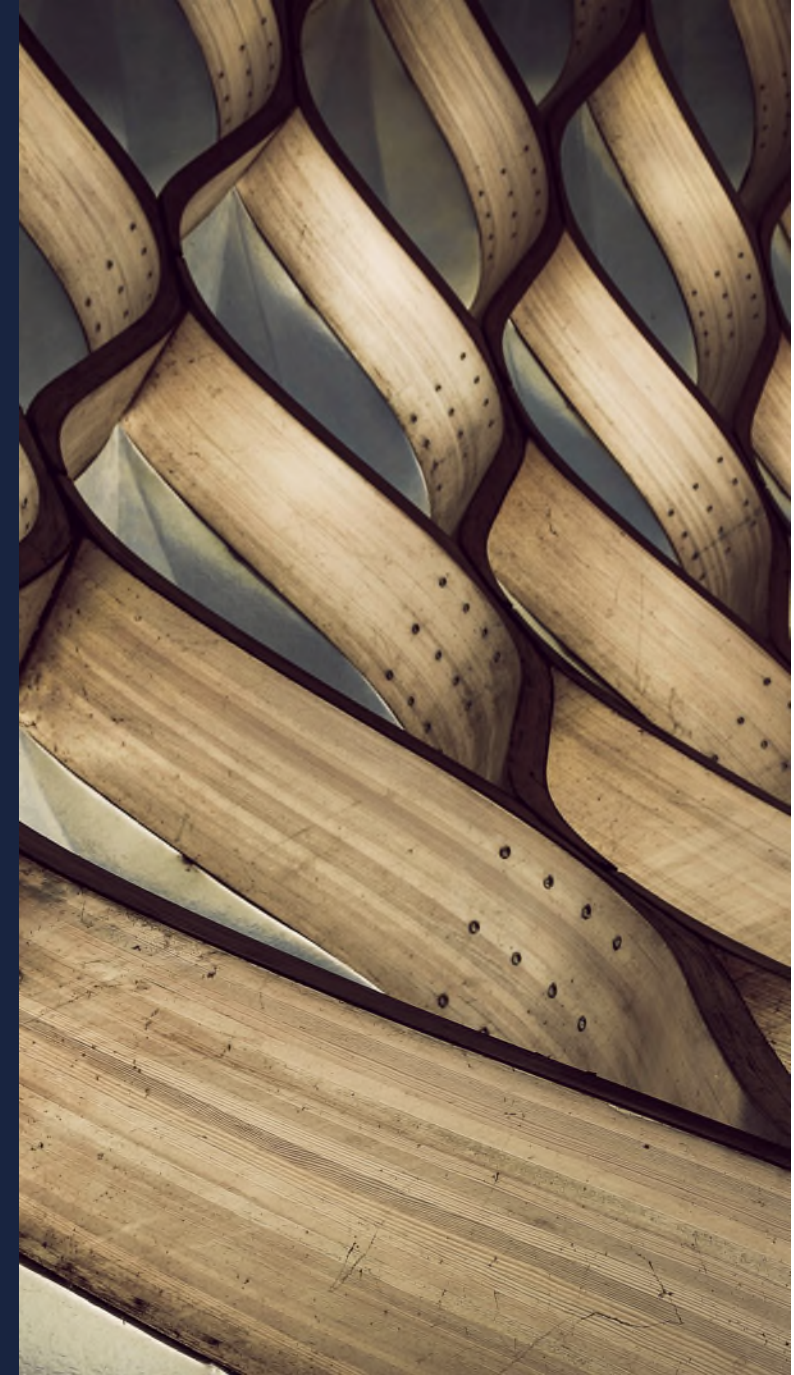




# Introduction

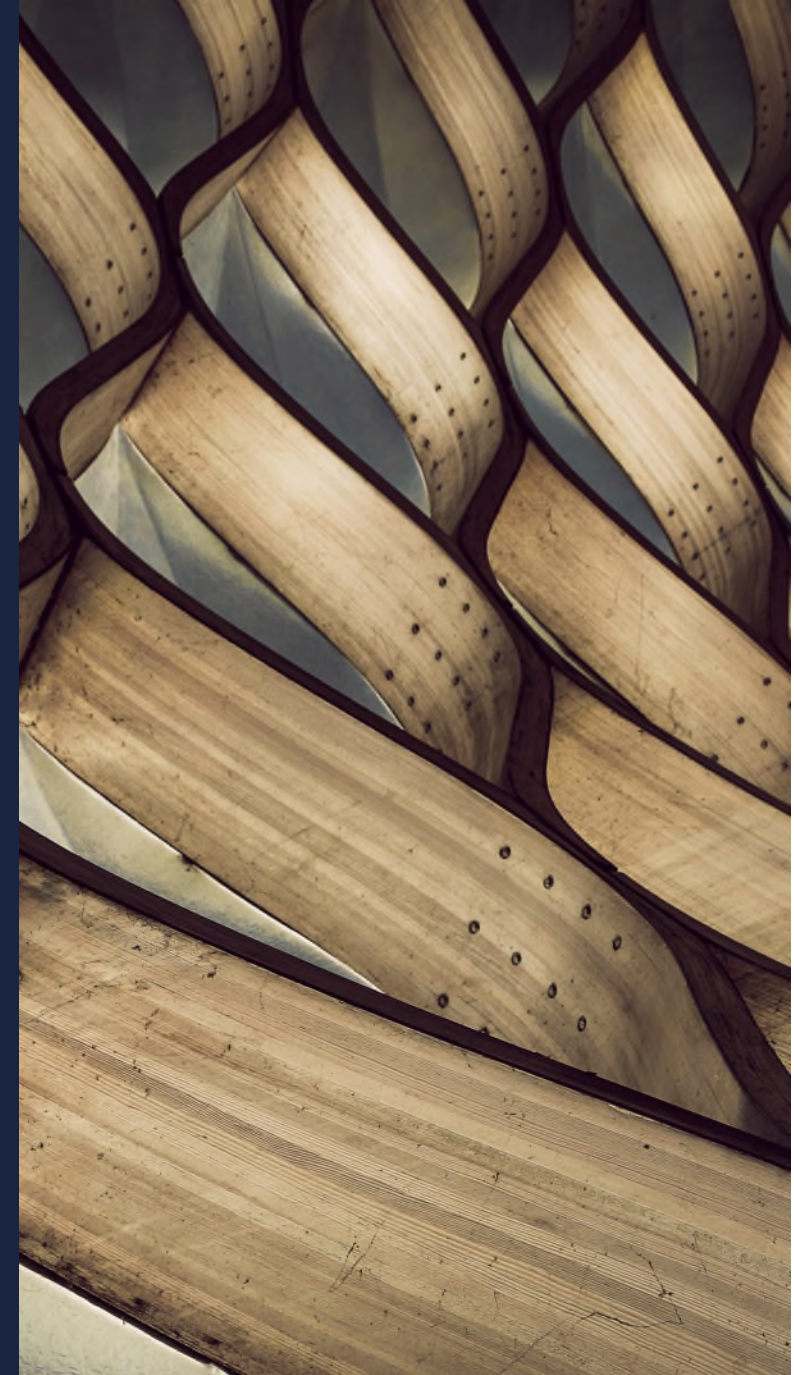
- Public procurement is a huge global market.
- The World Bank has stated that public procurement represents on average a total of 13% to 20% of GDP.
- The U.S. federal government is the single largest consumer in the world, spending more than \$650 billion on products and services each year. Various statutes, Executive Orders and regulations focus on the acquisition of “greener” products and services, and companies must understand how these laws affect public procurement.
- To realise their Nationally Determined Contributions and, generally, to attract investment and innovation in a range of sectors, Governments will need to further engage with the private sector on a domestic and international basis.
- Post COVID-19, many private sector businesses are looking to diversify into new and emerging jurisdictions.

# The objectives

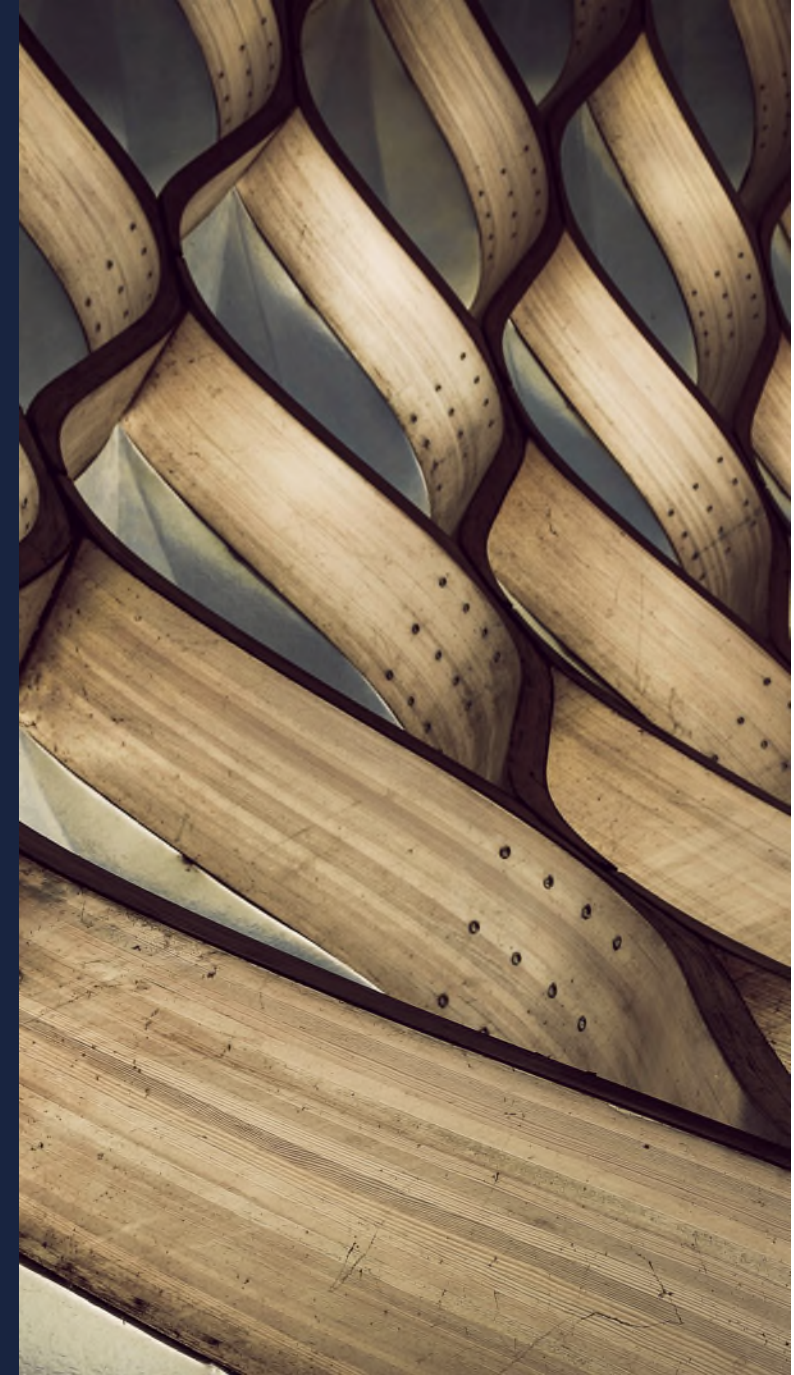




# United Kingdom

- GGC will include other insight features such as articles, webinars and spotlight interviews involving the UK, for example a comparison of the procurement challenge process in Belgium/US/UK.

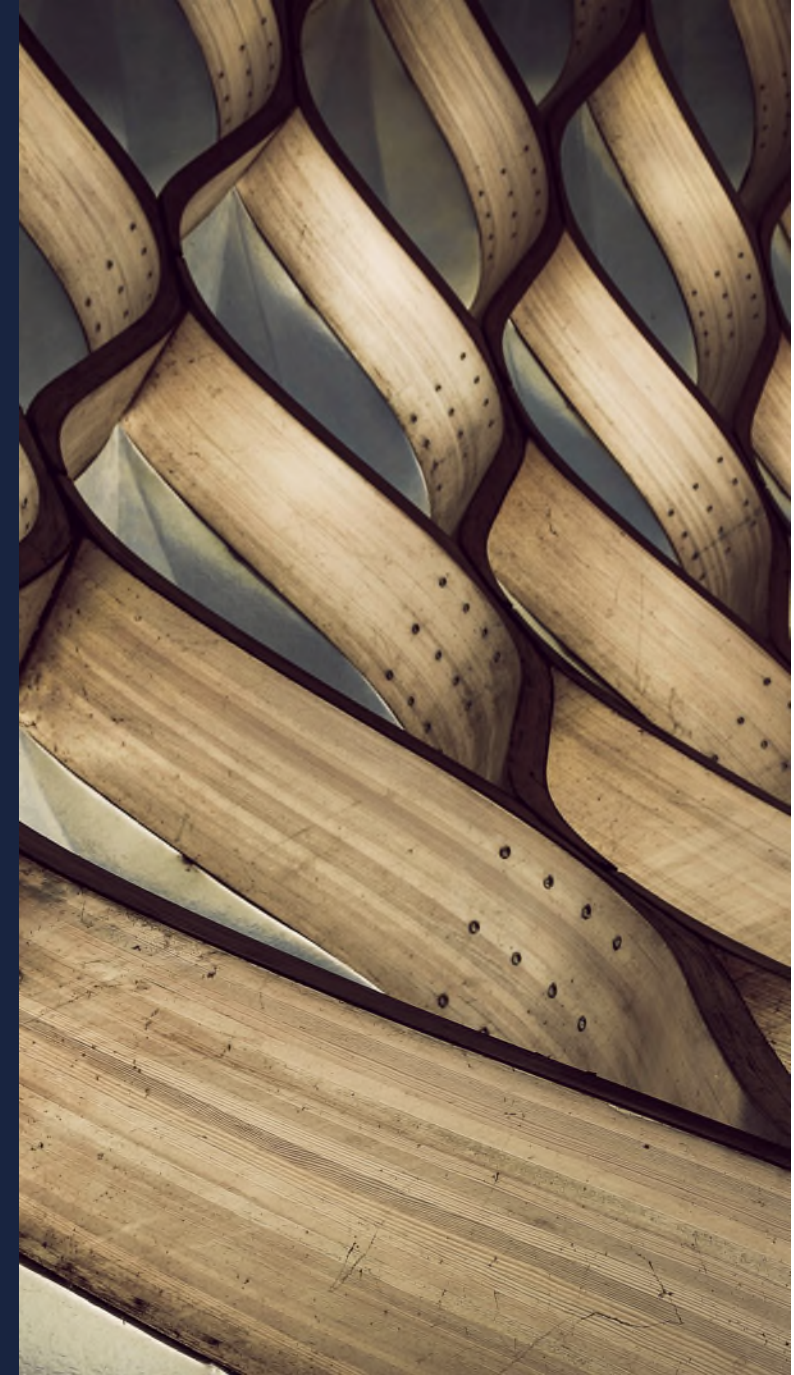

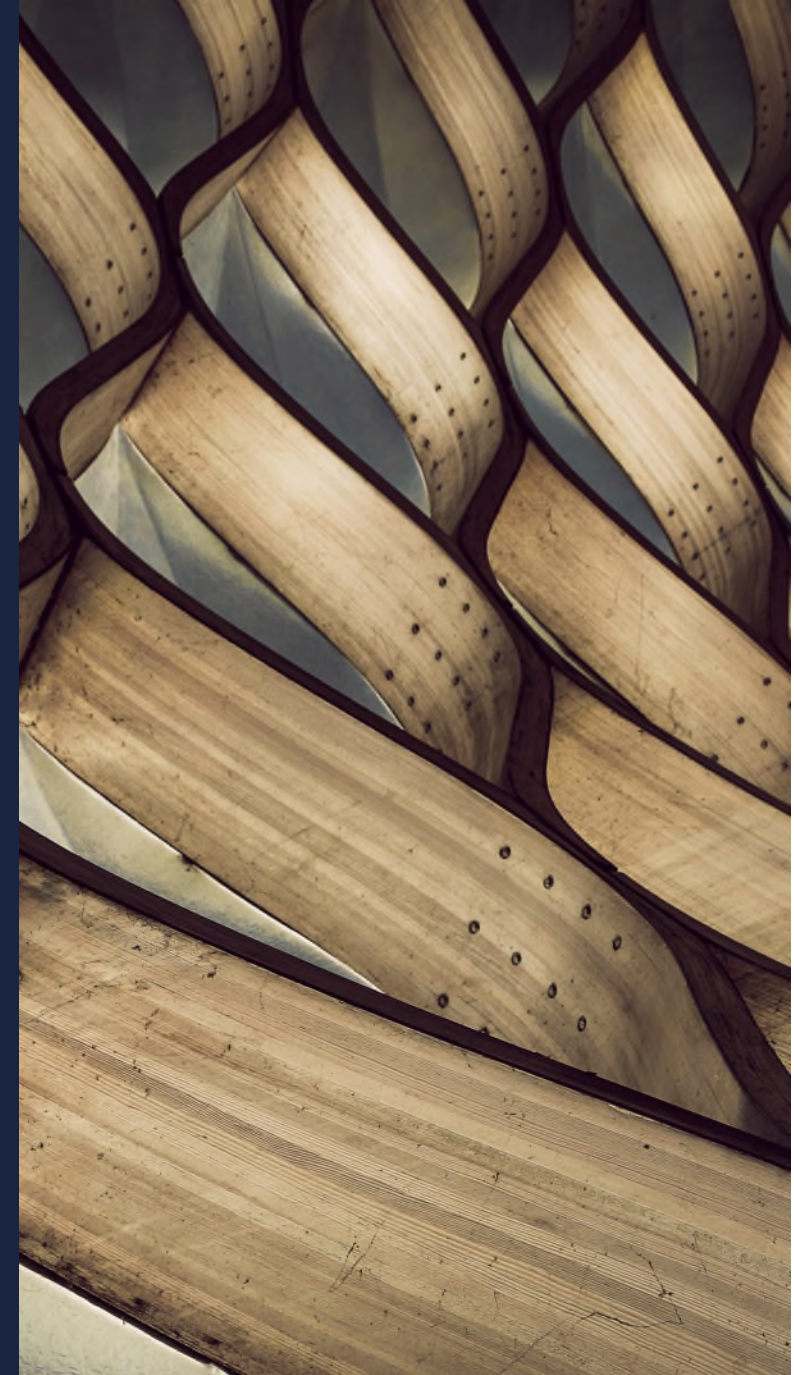

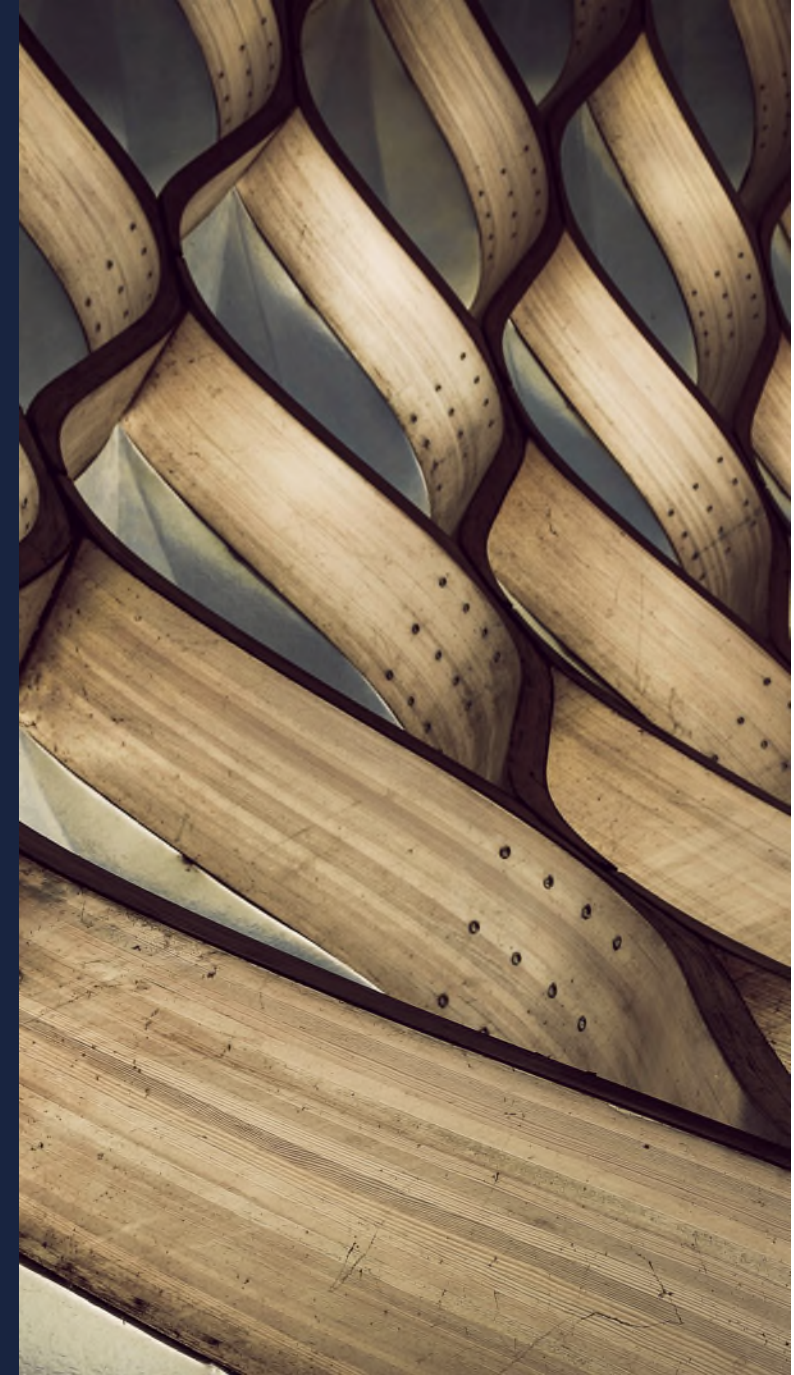
